**FX 2009 Rules and Regulations**

1. Assignment of space will be solely at the discretion of show management. Every attempt will be made to accommodate specific requests but not guaranteed.
2. Confirmation of space will be upon receipt of a signed contract with full payment. Outstanding balances will result in a delay of booth assignment and access to your booth space on show site. A \$25.00 late fee will be applied to all outstanding balances after **December 31, 2008**.
3. Two complimentary badges come with each 10'x10' space. Additional badges can be purchased for \$50.00 each. Dealers sharing a booth must pay for any additional badges above the complimentary two. Children 12 and under will be provided special badges at no charge. Children over 12 are considered adults and require an adult dealer badge. Children under 16 years of age are not allowed in the hall outside of exhibitor hours.
4. Any cancellations must be submitted in writing twenty-eight (28) business days in advance of the show. A \$25.00 cancellation fee will be charged. No refunds will be given after December 31, 2008. In the event of a cancellation, all promotional and/or incentive items must be returned or paid for at current market value.
5. Exhibitors signing up for the 2009 show at the close of the 2008 event with a signed contract and payment in full will do so at the 2008 price. This price will be frozen at the 2008 price indefinitely as long as a signed contract and full payment are received at the close of each year's show.
6. Set up and show times will be strictly enforced. To ensure a successful and professional show for dealers and customers, all dealers must have a representative in their booth during all hours of the show. In addition, tear down will not begin until 5:00pm on Sunday.
7. Show management reserves the right to revoke or refuse any application or to deny access to and/or remove dealers from the show at any time.
8. Exhibitors will comply with all OCCC operational policies as agreed to by Show Management. A copy of the OCCC operational policies may be viewed online.
9. Dealers and/or exhibitors accept full responsibility for any damages to booth and/or merchandise properties due to any cause. FX International, LLC accepts NO responsibility for any loss.
10. Dealers and/or exhibitors will comply with all local, state and federal laws and will not hold show management liable for any breaches, losses or damage to themselves or their property.
11. State tax is the responsibility of the vendor to collect according to state and county laws. Sales tax applications may be obtained by calling 850-488-6800 out of state or 800-352-3671 within Florida.
